Search Firm Contract for Chancellor Position, Chair Debra Hicks
 Regent Hutchinson moved approval of the search services contract. Motion seconded, motion passed

unanimously (Hicks, Mitchell, Hutchinson, Vela).

2. Chancellor Position Search Criteria, Feedback and Position Description

Search Planning Subcommittee Co-Chair Kari Mitchell

Members of the Board met with 40 stakeholders informally, then facilitated six statewide listening sessions and met with community college advisory board members to solicit input. The listening sessions were well received with over 400 people attending. Over 40 individuals provided written feedback through the website. Throughout the process, the description of the criteria, characteristics and common themes grew with stakeholder input. In addition, recommendations for advancement of the institution were offered. The position profile was formed from this vast stakeholder input, will direct the search criteria and will drive the solicitation, job description and contract.

Regent Mitchell moved approval of the chancellor position profile as the substantial framework, to be enhanced minimally by the search firm with non-material changes for the purpose of solicitation, with the removal of the word customer from the profile, and requiring eight years of relevant experience. The motion was seconded, and the motion passed (Hicks-yes, Mitchell-yes, Hutchinson-yes, Vela-no).

3. Chancellor Position Search Committee Composition and Appointments

Search Planning Subcommittee Co-Chair Kari Mitchell

The Board considered the complexity of the stakeholders of NMSU in fashioning the composition and members of the search committee. Approximately 53% of the members are from the academic community, 63% traditionally underrepresented, 47% external, and 53% internal. Of the internal members, more than half have been tenured and of the external members, almost 80% are alums. All are highly accomplished and esteemed in their fields and demonstrate passion for NMSU. Regent Mitchell moved approval of the search committee composition and appointments. Motion seconded, motion passed unanimously (Hicks, Mitchell, Hutchinson, Vela).
