#### **MINUTES**

A. Call to Order, Chairwoman Ammu Devasthali

#### Posting of Colors and Pledge of Allegiance Led by NMSU Army ROTC

Chairwoman Ammu Devasthali called the meeting to order at 3:33 PM, followed by the posting of colors and the Pledge of Allegiance, led by NMSU Army ROTC.

1. Welcome, College of Engineering Interim Dean David Jauregui

The Interim Dean of the College of Engineering, David Jauregui, welcomed attendees and thanked the Regents, administration, and advisory members for their dedication to NMSU. He highlighted key aspects of the College of Engineering, including its 14 bachelor's programs, 14 master's programs, and 6 PhD programs. Enrollment on the main campus is up 5% for both undergraduate and graduate students, while the global campus saw a 10% increase in undergraduate enrollment and a 25% increase at the graduate level. Dean Jauregui also noted that construction is progressing on the Thomas and Brown Replacement and the Ag Innovation Space expansion. Research expenditures have also been increasing, reaching over \$20 million in fiscal year 25, up from approximately \$19 million in fiscal year 24. The Dean then introduced several new faculty members from various departments, including Dr. Houqian Li, from Chemical and Materials Engineering, and Dr. Luis Guerrero from Mechanical and Aerospace Engineering, Dr. Raja Jayaraman from Industrial Engineering, Dr. Xianjue Deng from Civil Engineering, Dr. Mario Renteria Pinon from Electrical Engineering, Mr. Byron Calkins from Engineering and Technology Surveying Engineering (Geomatics), Dr. Venkata Siri Chirala from Industrial Engineering, and Dr. Francisco Torres Herrador from Aerospace Engineering.

Interim Vice President for Administration and Finance Chris Kinsley introduced Jake Nevarez, the new Assistant Vice President for Auxiliary Services. Mr. Kinsley noted that Jake has deep roots with the Aggie family and is a long-time director of the Corbett Center with a wide portfolio in auxiliary operations.

#### 4. Confirmation of Quorum, Chairwoman Ammu Devasthali

A roll call was taken, and a quorum was confirmed with Regents Gonzalez, Olivas, Saucedo, Romero, and Devasthali all present.

#### D. **Public Comment,** Associate Vice President Abby Butler

Associate Vice President Abby Butler confirmed that no one had signed up for public comment.

#### **E. Regent Committee Reports**

#### 1. Audit and Risk Committee Report, Regent Ricardo Gonzales

Regent Ricardo Gonzalez reported that the committee met on August 28, 2025. They discussed the Clery Act report and an internal audit update, and they approved the proposed audit plan and the minutes from the previous meeting. The next meeting is scheduled for October 23, 2025.

#### 2. Financial Strategies, Performance and Budget Committee Report, Regent Deborah Romero

Regent Deborah Romero reported that the committee met on September 9, 2025. They approved several capital project requests and action items, which were moved to today's consent agenda and action items agenda.

#### 3. Student Success Committee Report, Regent Christopher Saucedo

Regent Christopher Saucedo reported that the committee met on September 11, 2025. They reviewed academic program proposals and enrollment updates. They moved forward with proposals for the Doctor of Philosophy in Human Dimensions of Agriculture, the Master of Applied Artificial Intelligence, and the Doctor of Philosophy in Wildlife and Fisheries Ecology. These programs are before the board as action items on today's agenda.

#### G. Action Items

1. Human Dimensions of Agriculture (Education, Extension, Communication, & Innovation) - Doctor of Philosophy, Academic Department Head Richie Roberts

Dr. Richie Roberts presented a revised proposal for the PhD program, which has been updated to include a data-driven approach and a hybrid online format. The program has two student pathways: full-time students and online professional students. The program focuses on agricultural education, communications, leadership, extension, and government research with a focus on social sciences. The median salary for graduates is around \$82,000. The program has a waitlist of 21 New Mexico residents and strong stakeholder support. There are no additional faculty, library, or facility resources needed. A motion was made by Regent Saucedo and seconded by Regent Olivas to approve the program. The motion passed.

2. Applied Artificial Intelligence - Master of Applied Artificial Intelligence (online), Dean Enrico Pontelli

Dean Enrico Pontelli presented the proposal for the new online master's program, highlighting the increasing demand for AI-trained workers, with 15% of job postings at Sandia and Los Alamos national laboratories requiring AI skills. The program is structured as an "AI Plus X" model, which combines a core AI curriculum with a concentration in a specific discipline (currently sociology, agriculture, or manufacturing and supply chain). The program requires a bachelor's degree and a foundation in mathematics. There is an emphasis on the ethics of AI in the core curriculum. The program is supported by 25 faculty members from various colleges. A motion was made by Regent Olivas and seconded by Regent Saucedo to approve the program. The motion passed.

3. Wildlife and Fisheries Ecology - Doctor of Philosophy, Academic Department Head Martha Desmond

Dr. Martha Desmond and Casey Pregler presented the proposal for a PhD program in this field, noting its importance to New Mexico's outdoor recreation industry. There are no similar programs in New Mexico or the Southwest, which presents a significant opportunity. The program has two pipelines: students with a master's degree (4.5-year average completion) and students with a bachelor's degree (6-year average completion). The department has 9 faculty members and over \$31 million in active grants to support students, with no additional costs needed. A motion was made by Regent Saucedo and seconded by Regent Olivas to approve the program. The motion passed.

4. Chemistry Course Fee Requests, Operations Manager Lisa Osborne

Lisa Osborne and Dr. Shelly Lucetti requested to increase the course fee for two entry-level chemistry courses from \$5 to \$10 per student credit hour, which is an increase from \$20 to \$40 per course. The increase is needed to cover the cost of 100% cotton lab coats and goggles, which are required to meet higher safety standards. A motion was made by Regent Romero and seconded by Regent Olivas to approve the fee request. The motion passed.

#### 5. Nursing Anesthesiology Program Fee Request, Academic Department Head Alexa Doig

Dr. Alexa Doig requested to increase the semester-based program fee for the Nurse Anesthesiology Doctor of Nursing Practice program from \$1,000 to \$13,000. The fee increase will ensure students have access to essential resources, including a cadaver-based course, board certification preparation, and specialized equipment. Even with the increase, the program remains one of the most affordable in the nation. Graduating students can expect starting salaries of around \$300,000. A motion was made by Regent Romero and seconded by Regent Olivas to approve the fee request. The motion passed.

6. Capital Funding Amendment Request, Interim Vice President for Administration and Finance Chris Kinsley

Interim Vice President Chris Kinsley requested to amend the capital funding request to add a \$15 million demolition project for the Cole Village. This funding, if appropriated, would complete the demolition of phases 3 and 4. A third-party estimate adjusted for inflation confirmed the cost. Regent Romero noted that unforeseen issues, such as asbestos removal and utility line concerns, have contributed to the increased cost. The motion was made by Regent Romero and seconded by Regent Olivas to approve the amendment request. The motion passed.

#### H. Informational Items

#### 1. None.

1. Report from the New Mexico Department of Agriculture to the Regents of New Mexico State University (Board of Agriculture), Deputy Director Les Owen

Deputy Director Les Owen reported that the red imported fire ant quarantine in Doña Ana County was recently removed, a first for any area in the United States. He highlighted the collaboration between the department and NMSU scientists in achieving this. He also mentioned the success of the New Mexico State Fair and the "Get Your Fix, the Green Chili" campaign, which has promoted New Mexico's agricultural products across the country.

J. NMSU Academic Report, Interim Provost Lakshmi Reddi

Interim Provost Lakshmi Reddi presented the academic report, outlining the criteria for reviewing academic programs based on graduation and enrollment numbers. He noted that programs with low numbers will be reviewed to determine if they need assistance with recruitment and retention, or if they should be sunsetted. He showed data on some of the top-performing bachelor's and master's programs with high enrollment and graduation rates.

K. NMSU System Report, President Valerio Ferme

President Valerio Ferme gave a brief report, stating that the system is doing well, with enrollments increasing and fall-to-fall retention at its highest point. He concluded that the university is in a financially solid position.

A motion was made by Regent Saucedo to adjourn with a second from Regent Romero. The motion passed, and the meeting adjourned at 5:15 PM.

## SOUTHWESTERN PUBLIC SERVICE COMPANY UTILITY EASEMENT

THE BOARD OF REGENTS OF THE STATE AGRICULTURAL COLLEGE, AT LAS CRUSES, NEW MEXICO, NOW KNOWN AS NEW MEXICO STATE UNIVERSITY (collectively, the "Grantor," whether one or more), whose address is 6502 Quay Rd. AM 5, Tucumcari, New Mexico 88401, for the sum of TEN DOLLARS (\$10.00) and other good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, by this instrument does hereby grant to SOUTHWESTERN PUBLIC SERVICE COMPANY ("SPS"), a New Mexico corporation, whose address is 790 S. Buchanan Street, Amarillo, Texas 79101, an easement upon, under, over and across the property owned by Grantor located in the County of Curry, State of NEW MEXICO, more fully described as follows (the "Property"):

Being the description of a 30 foot wide utility easement, located in the Southeast Quarter of Section 6, Township 11 North, Range 31 East, N.M.P.M., Quay County, New Mexico according to the Warranty Deed recorded in Volume 15, Page 507 of the Quay County Clerks Records, Quay County, New Mexico.

#### SEE ATTACHED EXHIBIT

The Easement granted by this instrument (the "Easement") is subject to the following conditions:

- 1. SPS has the right to install, operate, relocate, construct, reconstruct, add to, maintain, inspect, patrol, enlarge, repair, and replace Utility Facilities for the transmission and distribution of electricity upon, over, under, and across the Property included in the Easement and to remove Utility Facilities from the Property, and the right of ingress and egress on Grantor's adjacent property for the same purposes. For purposes of the Easement, the phrase "Utility Facilities" shall include a variable number of conductors or wires, insulators, crossarms, protective devices, meters, terminal boxes, transformers, structures, poles, props, guys, anchors, and other necessary and desirable devices relating to electric energy or communication.
- 2. SPS has the right to remove all trees, branches, or other obstructions which might endanger or interfere with the operation, safety, or efficiency of Utility Facilities on the Property on which the Easement is located.
- 3. SPS will install and maintain Utility Facilities on the Property on which the Easement is located according to National Electric Safety Code in effect at the time of installation.
- 4. SPS shall enjoy the rights, benefits, and privileges conveyed by this instrument only until such time as the Utility Facilities on the Property are abandoned and removed, at which time all right, title, and interest of SPS in the Property will revert to the party that then owns the Property.
- 5. Grantor will have the right to use the Property for any purposes consistent with the rights granted to SPS by the Easement, provided that any use by Grantor shall not endanger the Utility Facilities or interfere with SPS's use of the Easement.
- 6. SPS has the right to assign all or part of the rights it receives under the Easement. The Easement will inure to the benefit of SPS and SPS's successors and assigns.
- 7. Grantor acknowledges and agrees that the location of the Easement is based only on preliminary surveys and that the rights granted by this Easement shall apply to the actual location of Utility Facilities, when constructed.
- 8. Upon completion of construction, SPS will reasonably compensate Grantor for the actual loss of crops or damage to crops on the Property caused by construction of Utility Facilities on the Property. It shall be the responsibility of Grantor to provide compensation to any lessee of Grantor or other tenant in interest.
- 9. Grantor binds Grantor and Grantor's heirs, successors, and assigns to WARRANT and FOREVER DEFEND, all and singular, the rights granted to SPS by this instrument.

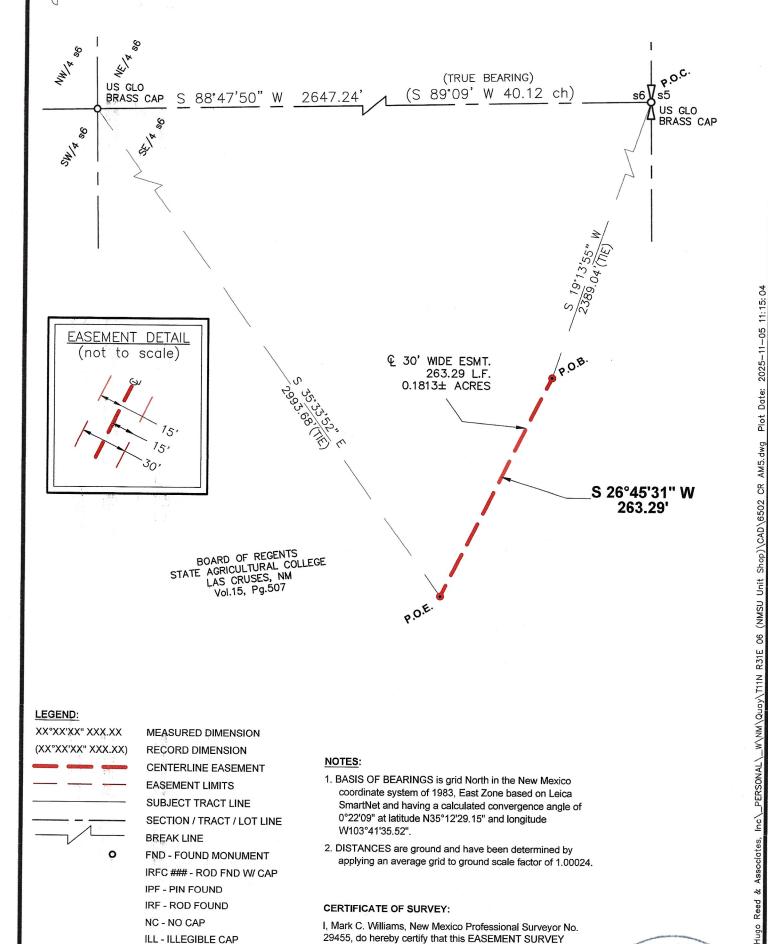

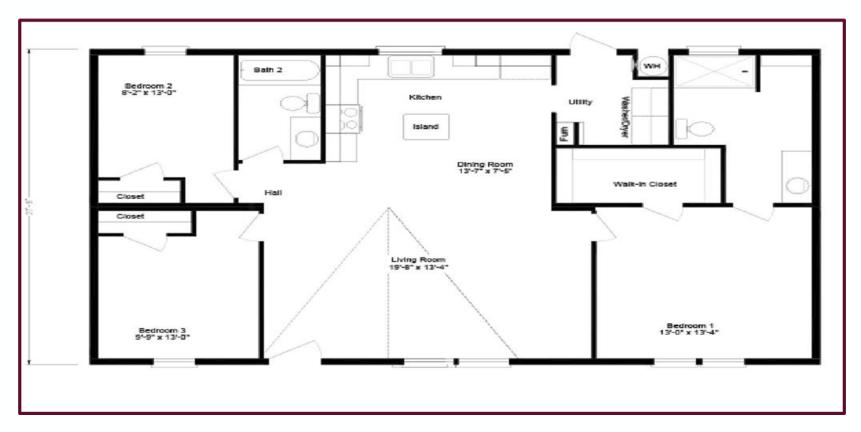

## **Project Rationale**

The New Mexico State University College of ACES, Agricultural Experiment Station (AES) has 12 agricultural science and research centers located across the state of New Mexico.

These centers serve as research facilities for faculty and staff to conduct research across New Mexico's varied geographical and environmental conditions. However, many of the sites are far from the main campus, remote, and have limited access to housing during research-intensive periods.

To facilitate and increase research opportunities at these remote centers, short to medium-term housing is needed to provide stable access for visiting students and researchers and to minimize research-related travel expenses. Meeting this housing need is critical for the success of off-campus-based research.

In Fiscal Year 2024 (FY24), state capital funding was allocated to support the development of housing for the second group of seven prioritized units, located at Leyendecker, Fabian Garcia, Artesia, Alcalde, Tucumcari, Clayton, and College Ranch.

The previous set of prioritized housing units was installed at Clovis, Farmington, Los Lunas, and Mora (AES), funded by Fiscal Year 2023 (FY23) General State Funds.

We are pleased to offer you the role of Vice President, Administration and Finance at New Mexico State University (NMSU) in Las Cruces. This is a vital role at NMSU reporting directly to the President, and one we believe you will perform well based on your qualifications and experience.

As Vice President, Administration and Finance (VPFA), you will perform duties and obligations commensurate with your position, as well as others that may be assigned. The effective date of this appointment is January 7, 2026. The annual base salary for this appointment is \$335,000. An additional one-time payment of \$10,500 will be paid after you complete the first six months of employment, limited to the first year only. Salary for this at-will position is payable twice monthly while employed.

Upon completion of your first two weeks of employment, you will also be provided a one-time payment of \$15,000 in lieu of allowable moving expenses. You will also receive a \$12,000 allowance for temporary housing for three months. All payments are subject to mandatory federal and state taxes and withholding.

In addition, if NMSU elects to end the employment relationship within the first calendar year, and if the dismissal is not "for cause," you will be provided with six months of base salary in exchange for a release of all claims, along with your continued services in a transitional role as Special Advisor to the President during the six months following NMSU's appointment of an Acting or Interim VPFA (the Transitional Term). #### 1. Purpose

The purpose of the Governance Committee of the Regents of New Mexico State University (the "Committee") is to advise and provide strategic direction to the Board of Regents, and to develop, review, and amend employee compensation and benefits programs and policies for the Board's consideration. In addition to these specific responsibilities, the Committee also plays a broader role in ensuring that the Board of Regents functions effectively as a governing body. This includes advising the Board on best practices in governance, promoting transparency and accountability, and fostering a culture of collaboration and consensus-building.

#### 2. Membership

The Committee shall consist of the following members:

- The Chair and Vice Chair of the Board
- The President of the University System
- The Secretary/Director of the New Mexico Department of Agriculture
- University General Counsel
- Associate Vice President for Human Resource Services

A 6% increase in the housing rate is estimated to generate an additional \$1,000,000 in funds to be allocated to housing maintenance.

# **Summary of Request**

- Housing Rates were not increased for Fiscal 2024-25.
- Housing Rates were increased by 3% for Fiscal 2025-26.
- The FY 26 rate, which increased and is estimated to generate \$525,000, has been dedicated to housing facility maintenance.
- Through Oct. 31<sup>st</sup>, \$546,904.99 has been encumbered for emergency housing repairs PO's, leaving no funding for preventative or deferred maintenance. As of 10/31/25, a total of \$1,233,092 has been spent through Sodexo on facility maintenance.
- A 6% funding request is estimated to generate an additional \$1,000,000 towards housing maintenance.
- Housing occupancy has increased to 99%, despite the 3% rate increase.
- NMSU has no plans to add a new residence hall; it is thus even more critical than ever that all
  existing housing be maintained.

# **No Inflation Adjustment**

- Although CPI has increased by 3% for 2025, the Administration is not seeking a CPI adjustment.
- CPI at 3% + a 6% maintenance increase would = 9%
- Administration and Finance is requesting 6%

# Larger Maintenance Projects (July 1 through October 31, 2025

- Pinon Hall Heating System Failure (Steam) Fix \$17,518.09
- Chamisa Hall Heating System Failure Fix \$264,121.76
- Chamisa Hall Replace 28 failed compressors \$185,850
- Chamisa II Envelope Repairs Exploring costs to repair stucco and roofs.
- Cervantes, Tom Fort, VDM Heating System winterizations \$121,458.54
- Chamisa mechanical room repairs \$27,254.54
- Garcia Hall HVAC system repairs \$167,034.21
- RGH Steam issue repairs \$80,783.72
- Tom Fort and Cervantes have 20-plus-year-old furnaces that need to be changed. Exploring the possibility of installing mini-splits AC/Heat units.



# Limited Contingency for the rest of FY 26

- NMSU is approaching the winter season; this will typically stress buildings, resulting in larger repair costs.
- Increased occupancy leads to increased usage and wear and tear.
- NMSU Housing has been unable to build an R&R reserve, given pressure to make emergency repairs.
- Until an R&R reserve builds up over time, both Preventative Maintenance and Planning will suffer.

# **Increasing Demand for On Campus Housing**



For Fall 2024, NMSU Housing had a 90% Occupancy, and 427 student wait listed.



For Fall 2025, the practice was changed, so that upperclassman, primarily second year students can request to be placed on a wait list for unallocated spaces traditionally reserved for first year students.



2025 Occupancy is 99% with 3,093 beds assigned of the 3,133 available.

# Increasing Demand for On Campus Housing — Part II



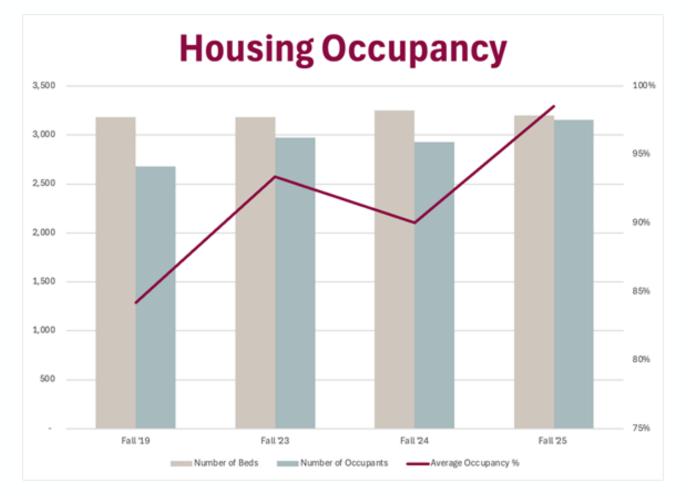
Fall 2026 Occupancy may reach or exceed 100%. While excessive capacity is a positive financially, adding additional occupant spaces, (EX: converting doubles to triples) can decrease student satisfaction with residential experience.



Building codes ultimately dictate the maximum building occupancy.



For students from outside Doña Ana County, the lack of on-campus housing or affordable off campus housing negatively impacts both recruitment and retention.

# **Housing Challenges**



Capital renewal needs are estimated between \$220 - \$280 million.



Maintaining the existing housing stock is presenting real financial challenges. Some of the oldest buildings date from the 1940s and 1950s.



Over 50% of NMSU housing facilities need of renovation or replacement.



Housing is experiencing the same maintenance issues as the academic facilities, but without the benefit of the State Building Repair funds provided to NMSU instructional facilities.

# INFORMATIONAL REPORT SUMMARY OF ARP REVISIONS (PERIOD: 9/01/2025-11/30/2025)

This informational report is submitted pursuant to ARP 1.10 (Part 5.5.B.) and includes a summary of approved policy actions between September 1, 2025, through November 30, 2025.

#### **AMENDMENT:**

#### ARP 4.81 - Degrees, Majors, Minors and other Academic Programs of Study

Upon approval by the President, the operational policy was amended effective November 12, 2025. Along with non-substantive changes, this amendment adds language 1) that addresses the requirement for a teach-out plan for students when a program of study is inactivated, and 2) that states the Provost and Chief Academic Officer can ask for a review of programs of study for sustainability and viability.

#### NEW:

#### ARP 15.82 - Digital Accessibility

This new operational policy was approved by the President and is\_effective November 12, 2025. The purpose of this policy is to demonstrate that New Mexico State University is committed to supporting information technology that provides individuals with disabilities an equal opportunity to participate in University programs and services. Implementation of this policy ensures all individuals have access to Digital Content, Resources, and Technology ("Digital Material") provided by or on behalf of the University. Creation of this policy was part of NMSU's resolution agreement with the Office of Civil Rights. (OCR Complaint No. 08-23-2211).

#### ARP 4.04 - Professional Licensure and Certification Disclosure

This new operational policy was approved by the President and is\_effective November 12, 2025. The policy ensures that NMSU provides clear and accurate information to enrolled and prospective students about academic programs, particularly those leading to professional licensure or certification. According to §668.14(b)(32), institutions must disclose whether their programs meet or do not meet the educational requirements for professional licensure in each applicable state. By providing this information to students, they can make informed decisions regarding their education and career paths.

#### **BOARD OF REGENTS REPORT**

December 11, 2025

#### **Noxious Weed Management Program:**

Using its distribution from New Mexico's Land of Enchantment Legacy Fund, NMDA is running a Fall FY26 cycle of its Noxious Weed Management Grant. In the Spring FY26 cycle, NMDA awarded \$740,000 to 18 projects that map, monitor, treat or eradicate state-listed weed species that adversely impact local communities and the environment.

#### **NMDA State Laboratory:**

The State Chemist Laboratory will undergo an ISO/IEC 17025:2017 assessment for accreditation December 17-18, 2025. The Metrology Laboratory has made its submittal to NIST (National Institute of Standards and Technology) for recognition and traceability for 2026-2027 as well as requested an assessment for ISO/IEC 17025:2017 accreditation.

#### **Senate Memorial 19 Report:**

In accordance with Senate Memorial 19 (SM 19), NMDA and NM Public Education Department staff assembled a workgroup to develop a plan in which 50% of New Mexico beef, cheese, milk and produce grown and made in New Mexico is served in public school meals. The workplan was completed and submitted by the November 1, 2025, deadline. Staff presented the SM 19 workgroup plan to the Water and Natural Resources Committee in Santa Fe November 18, 2025.

#### NMSU Ag Day 2025:

The 12th annual NMSU Ag Day 2025 was held on Saturday, November 8th, 2025, at New Mexico State University, coinciding with Aggie Homecoming and featuring family fun, food samples, and educational booths from NMDA, NMSU's College of Agricultural, Consumer, and Environmental Sciences (ACES), and industry partners. The free street festival ran from 11 a.m. to 2 p.m. in the Pan American Center lots, and celebrated New Mexico agriculture with hands-on activities and community spirit.



#### **Rounders Award:**

On October 15th, 2025, two new recipients were honored with the New Mexico Rounders Award, established by the NMDA to celebrate people living the Western lifestyle. This year's recipients were Randy Huston and Jim Keith. Randy Huston is a New Mexico rancher, rodeo competitor, and acclaimed singer-songwriter known for songs recorded by major artists, and Jim Keith is a farrier and blacksmith, recognized for his craftsmanship in horseshoeing and blacksmithing. The award, named after Max Evans' book "The Rounders," is given to artists who preserve New Mexico's cowboy culture. It's a significant cultural recognition for artists, musicians, and craftspeople embodying the state's heritage.



#### **NMDA Annual Conference:**

The NMDA Annual Conference was held October 22nd-23rd, 2025, in Las Cruces. Our Annual Conference is a once-a-year gathering of all employees, many of whom are stationed around the state administering laws on producer/consumer protection, fair markets, and natural resource management, as well as overseeing areas such as pesticides, weights & measures, feed/seed, and plant health, and ensuring compliance with state statutes. It is also a time to recognize staff

members who have gone above and beyond in their roles with NMDA and in their communities, and to introduce new employees hired within the past year.



#### **Matriarchs of New Mexico Agriculture:**

2025 marks the inaugural year of NMDA's "Matriarch of New Mexico Agriculture" campaign. The purpose of this new campaign is to recognize the respected, hard-working, and often humble women in New Mexico Agriculture who have devoted most of their lives to improving our state's agriculture industry, their community, and their family. These women are leaders, mentors, and advocates. The 2025 Maiden Matriarchs, Margie McKeen and Mary Alice Garay were recognized during this year's Ag Day festivities and will be featured on TV and other digital platforms beginning in January.



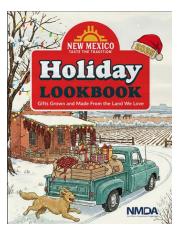
#### HomeGrown:

A New Mexico Food Show and Gift Market- Since 2014, this two-day signature event attracts local vendors, suppliers, shoppers, foodies, chefs, and media while promoting the awareness and sales of locally grown and made NM products just in time for the holiday shopping season. 2025 event highlights include: 81 vendors included 41 New Mexico Taste the Tradition®/Grown with Tradition® members; 5 food demos utilizing the NMDA food trailer and recipes developed by Chef Ambassador Becky Windels. Attendees could also bid on decorated Christmas trees and wreaths provided by various Dona Ana County 4-H clubs. This served as a fundraiser for the agriculture-based youth organization while also adding to the holiday atmosphere. 4-H members also had booths where they could sell handcrafted items related to their 4-H projects.



#### **Holiday Lookbook:**

This year's New Mexico- Taste the Tradition® Holiday Lookbook launched on Thanksgiving Day. The Lookbook is a 38-page digital shopping guide intended to entice consumers to support local agribusinesses during the holiday season. #### **Grant Programs Status Update:**

As a result of the federal government's ongoing review of grant programs administered by NMDA, updates, and status of three (3) core USDA grant programs are provided below:

Local Food Purchase Assistance Program (LFPA) - The Food Depot and New Mexico Farmers Market Association sub awardees have submitted their final invoices for grant close-out.

Resilient Food Systems Infrastructure Program (RFSI) - All subcontracts are fully executed for total awards of over \$3.5 million. The twelve Equipment Only subcontracts end December 15, 2025; therefore, all subgrantees are finalizing their bridge loans and/or making final equipment purchases before the upcoming USDA deadline. The six Full Infrastructure projects have an additional year to complete their projects. Several have/are requesting changes to their originally approved projects. Staff are working through informal and formal amendments as needed.

New Mexico Local Meat Processing Grant (LMPG) - Staff completed the subaward process for the LMPG grant and issued award agreements for ten projects totaling over \$2.8 million. Successful meat processing businesses have three years to complete their approved projects. Pictured below: High Country Meats of Raton, NM completed the first purchase under the LMPG grant of a Jacketed Kettle, used to reduce beef fat waste and create value-add tallow products.



#### **International Marketing:**

National Association of State Departments of Agriculture (NASDA) "A Taste of the States" Pavilion, at the Americas Food and Beverage Trade Show in Miami, FL - Staff participated in one-on-one meetings with prequalified buyers, importers and distributors from Canadian and

Latin America Markets. NASDA featured a New Mexico company during their tradeshow product showcase. September 8-13, 2025



Western United States Agricultural Trade Association (WUSATA) - Southeast Asia Inbound Trade Mission to NM: Staff hosted a delegation of bakery ingredient buyers who participated in one-on-one meetings with New Mexico food processors. The trade mission also included area site visits and tours. September 11-13, 2025



European Union Inbound Trade Mission to NM - Staff hosted a delegation of specialty food buyers from across Europe. The trade mission included one-on-one meetings with consumer ready-food suppliers and manufacturers. Delegates also participated in site visits to area food manufacturing facilities. October 22-24, 2025



New Mexico Pecan Outbound to ANUGA - Staff led a delegation of NM pecan growers and shellers to ANUGA Trade Show in Cologne, Germany. ANUGA is one of the largest food trade shows in the world. The NM cohort met with prequalified tree nut buyers, importers and distributors through a series of B2B events. The outbound also included a chef promotion featuring NM Pecans. October 1-8, 2025



United States Livestock Genetics Export Inc. (USLGE) - USLGE Inbound to New Mexico and Kansas: In partnership with the Kansas Department of Agriculture, staff hosted a delegation of seed stock buyers from Mexico. The delegation visited eight (8) seedstock operations throughout New Mexico.
