Corporate Partnership Tuition Rate

## **Requested Action of the Board of Regents:**

Approval of extending the \$250.00 cost per credit hour to corporate partnerships, such as Amazon.

## **Executive Summary**

Dona Ana Community College (DACC) and NMSU Global secured a partnership with Amazon to become part of their Career Choice offering, which allows employees across the globe to take courses/programs throughout the NMSU system. Amazon provides \$5,250 tuition reimbursement, which is a common practice for organizations. Federal tax law allows employees to get up to \$5,250 in tuition reimbursement tax free from their employer every year. This means that up to that \$5,250 cap, you don't have to declare tuition reimbursement on your federal income taxes, as long as your company has a written policy, and the policy meets all federal tax guidelines.

As NMSU begins to develop and grow corporate partnerships across our system, with Amazon being the first, offering a specific corporate tuition rate based on minimum enrollment numbers would incentivize additional organizations to encourage their employees to purse higher education within our system. This would not only benefit the NMSU system financially but also enhance our reputation as a preferred educational institution for working professionals. This, in turn, can lead to a more skilled and knowledgeable workforce, benefiting both the organizations and the overall economy. Additionally, such partnerships can create opportunities for internships, research collaborations, and job placements, further strengthening the ties between NMSU and the organizations where students will seek employment.
